## **Compliance verification EU**

It is the responsibility of the converter or packer to verify for the finished product the overall and the specific migrations required by Regulation (EU) 10/2011, as well as the sensory performance.

The overall migration should not exceed the Overall Migration Limit (OML) of 10 mg/dm2 (60 mg/kg of simulant). For each substance subject to specific migration (see table above), the migration of the substance should not exceed its limit (SML). For further details about migration testing, please refer to the current version of the regulation (EU) No 10/2011.

Please note that some tests have been performed on the base polymer and that it can be used under any food contact conditions at a temperature exeeding 40°C, and with foods for which point 4 of Annex III assigns simultants A, B, C or D1 and can be used under any long term storage at room temperature or below, including when packaged under hot-fill conditions, and/ or heating up to a temperature of 70°C for a maximum of 2 hours and up to a temperature of 100°C for a maximum of 15 minutes.

Formfutura filaments are manufactured from compounds containing a mixture of raw materials rather than an article. Therefore, Formfutura requested information from suppliers providing raw materials contained in the above-mentioned filament. The information provided in this statement addresses the compositional requirements of Food Contact Notifications (FCN). The composition of the above-mentioned filament meets the requirements for use in articles under Food Contact Notifications (FCN) for all food types, except alcoholic foods, infant formula and human milk and conditions of use C (hot filled or pasteurized above 150 °F / 65°C) to G (frozen storage with no thermal treatment in the container). Please note that it is the responsibility of the manufacturer of the finished articles to ensure compliance with FDA extraction testing requirements according to the final use.
